Main objectives	Performing professional translation activities and delegated duties depending on supervisor's specialization and instructions and according to <b>MSF</b> protocols, standards and procedures, in order to ensure a proper representation and translation of <b>MSF</b> activities and core values.
Main responsibilities and tasks	<ul> <li>Accompany international medical staff during field visits to health facilities, IDP camps, and mobile clinics to provide interpretation during medical consultations and technical discussions with local counterparts.</li> <li>Facilitate communication with local health authorities (e.g. Directorate of Health) regarding referrals, MoUs, patient care coordination, and reporting, particularly in sensitive or high-security contexts.</li> <li>Support the Mental Health and Health Promotion teams in translating IEC materials, counseling scripts, and community awareness content, ensuring cultural and linguistic accuracy.</li> <li>Assist in patient surveys, focus groups, or community feedback mechanisms by translating questionnaires and supporting interviews when health-related data is collected.</li> <li>Flag cultural misunderstandings, communication barriers, or potential conflicts of interest to supervisors, especially in contexts involving gender norms, confidentiality concerns, or sensitive clinical cases.</li> <li>Contribute to the development and review of localized medical materials used in the Syrian context, ensuring consistency in terminology and relevance to the setting.</li> <li>Support translation tasks related to medical emergency preparedness, outbreak response, or vaccination campaigns, ensuring accurate dissemination of health information to communities.</li> <li>Provide language support to other departments (HR, Logistics, Operations) only when tasks are directly related to medical activities or coordination with medical actors.</li> <li>Observe all MSF protocols regarding safety, ethics, and confidentiality, particularly in areas of heightened security or population displacement.</li> </ul>
