1. Job Summary:

The Obstetrician and Gynecologist is a medical doctor specialized in providing comprehensive reproductive health services to women and girls in clinical setting. The Obstetrician and Gynecologist will collaborate with other health professionals, such as midwives, nurses, and pharmacists. The Obstetrician and Gynecologist is responsible for diagnosing, treating, and preventing reproductive health conditions, such as pregnancy complications, infections, cancers, and injuries. The Obstetrician and Gynecologist also participates in promoting reproductive health and rights and preventing gender-based violence and harmful practices.

To perform this job successfully, an individual must be able to perform each essential function with or without reasonable accommodation.

2. Scope of Work

The Gynecologist will be responsible for the following activities:

- Perform clinical consultations and examinations of women and girls, and provide appropriate diagnosis, treatment, and referral for reproductive health conditions, such as pregnancy complications, infections, cancers, and injuries.
- Provide family planning services and counseling, and offer a range of contraceptive methods, such as pills, injections, implants, and intrauterine devices.
- Provide antenatal, and postnatal care, and family planning
- Provide screening and treatment for cervical cancer, breast cancer, and other gynecological cancers, and refer patients to specialized care when needed
- Provide screening and treatment for sexually transmitted infections, including HIV, and provide counseling and support to patients and their partners
- Provide care and support to survivors of gender-based violence
- Document and report all reproductive health-related activities, outcomes, and incidents, and maintain accurate and complete records
- Participate in the assessment and analysis of the reproductive health situation and the reproductive health needs of the target population, and identify and prioritize the gaps and challenges
- Participate in the evaluation and improvement of the reproductive health services and provide feedback and suggestions for adaptation and innovation.
- In case inpatient services are available in the facility conduct daily ward round and ensure quality of services.
- In case responsibilities are assigned as head of the unit, ensure proper organization, staff Rota, discipline and coordination of services with staff and other sections in the health facility.

- Ensure availability to attend obstetric emergencies at the health facility.
- Ensure implementation and monitoring of health data in patient charts and reporting tools.
- Participate and lead quality assurance mechanisms in the unit such as CMEs, mortality and morbidity audits and quality assessment.

Perform other duties as assigned. The duties and responsibilities listed in this document are representative of the nature and level of work assigned and not necessarily all inclusive.

3. MINIMUM QUALIFICATIONS

- Typically, a bachelor's degree or equivalent in medicine from a recognized institution.
- Postgraduate degree or diploma in obstetrics and gynecology or equivalent from a recognized institution.
- Valid license or registration to practice as an Obstetrician and Gynecologist
- At least five years of relevant experience as an Obstetrician and Gynecologist in a hospital setting, preferably in a low-resource or humanitarian context.
- Proficient in the use of reproductive health equipment, supplies, and drugs, and familiar with the comprehensive reproductive health services and protocols.
- Able to perform clinical consultations, surgical procedures, and interventions independently and effectively.
- Able to diagnose, treat, and prevent reproductive health conditions promptly and appropriately.
- Able to work under pressure and in challenging conditions, and to cope with stress and uncertainty.
- Able to communicate and collaborate with other health professionals and patients from diverse backgrounds and cultures.
- Fluent in English and the local language, and able to read, write, and speak clearly and accurately.
- Committed to humanitarian values and principles, and respectful of the dignity and rights of the patients and the communities.
